- 1. Call to Order
- 2. December 2, 2010 Meeting Minutes approved and seconded
- 3. Action Item TRAC By-laws approved and seconded
- 4. Action Item 2010 goals
 - A. Presentation by Elizabeth on TRAC 2010 Goals (Handout)
 - B. Questions What is the total number of bust stops; answer 3500
 - C. Discussion over reduced price fare cards for people age 65 and people with disabilities reduced price information located with schedules.
 - D. Question can age be lowered to 62 (the same age that one can collect Social Security); answered by Brad would need to do analysis of riders that age and how to attract more seniors to riding. Discussion of collaborating with agencies to recruit volunteers to give seniors (and people with special needs) individualized instruction on riding the bus.
 - E. Suggestion to include locations for grocery stores, drug stores, etc. on schedules; use to increase revenue example, sell space to HyVee, Walmart, etc.
 - F. Contact Elizabeth or Gini if interested in working on specific goals.
 - G. Action on TRAC goals tabled until next meeting

- 4. Discussion Item FY 2011 Budget Update
 - A. Presentation by Brad on Proposed Service Reductions (Handout).
 - B. Thank you to TRAC members who attended public input meetings; over 100 people attended one meeting and over 60 emails/comments generated.
 - C. Issue with bus service south of airport public comments about losing jobs if bus service is cut.
 - D. Issue with ending service at 8:45pm people who work at malls will not be able to get home.
 - E. Would like to be able to get additional insurance for accident coverage.
 - F. Looking at refinancing debt for accident liabilities already incurred.
 - G. Money for public transportation may be allotted in jobs-focused stimulus bill.
 - H. Service adjustments need to be implemented by April 25, 2010 in order for there to be carryover savings in the current fiscal year.
 - I. In coming time expect comprehensive planning sessions to incorporate suggestions and with less focus on individual services and route cuts and more on a comprehensive system.
 - J. Mary asked about cost effectiveness of hybrid buses- Elizabeth answered that she has compiled most of the information, but still has some follow-up questions with maintenance.
 - K. Helen On-Call drivers have mentioned that they have not had the opportunity to talk management about ideas for improvement; Brad answered that he has talked to over 100 employees.
 - L. Brad has worked with the union to address issues and all drivers have been publicly invited to give comment. Helen specifically West Des Moines On-Call; collaborate with management out there.
 - M. Discussion on fostering environment where people feel comfortable raising concerns.
- 5. Discussion Item Bus Service and Bus Stop Safety/Accessibility Concerns:
 - A. Mary meeting with Access Advisory Board parking meters are placed in areas that may be too close to bus stops, but are within legal city ordinance. Talk of moving/rearranging parking meters so that there will be more room 6 targeted areas: Ingersoll Ave., Beaverdale area, Methodist Hospital, Drake University, Broadlawns Hospital, and certain parts of East Village.
 - B. Snow removal issues for bus stops with a bench- there is a contract with

Creative Outdoors to remove snow, but did not do a good job this winter. Has been addressed. Shelters are responsibility of DART to clear snow. At standing bus stops (by poles with signs) it is the responsibility of the property owner to clear the snow. The issue with this is that they are only required to clear the sidewalk. Call the Public Works Action Center who gives a warning to clear snow within 36 hours at risk of a fine.

- C. Mary said they gave a presentation about how accessibility is beneficial to everyone. Talked about outreach to public about educating them on the issue. There is no ordinance on snow removal between the sidewalk on the curb and the focus will be on appealing to the public to clear the bus stop similar to how people are asked to clear the snow around a fire hydrant.
- D. Issue with DART clearing certain areas on major arterioles is that then sets a precedent to always clear the areas, which could lead to having to clear all bus stops.
- E. Current recourse is working with city council to change ordinance to require property owners to clear snow on their easements.
- F. Look at bus stops as year-round stops as opposed to seasonal ridership have riders send in pictures of their bus stops for evidence to justify changing ordinance.

For 2010 the Transit Riders Advisory Committee would like to accomplish the following goals:

- Increase Ridership
- Increase Number of Sheltered Stops

Below outlines strategies to best accomplish these goals:

- 1) Increase Ridership among the following customer groups.
 - a. Seniors DART has not recently done any targeted advertising to senior citizens

ACTION STEP: Promotion offering free rides on DART fixed route services on a set day every month to seniors. DART will promote the "Free Day" with senior centers, senior apartments, etc.

TIMELINE: SPRING 2010

b. Schools - DART has a contract with Des Moines Public Schools offering free rides after school, weekends and all day during breaks. Last year staff did present DART service info to 4 schools last year.

ACTION STEP: Promote riding DART to jobs, the mall, etc during school breaks. Also, contact schools regarding participating in Earth Day events.

c. Persons with Disabilities - DART currently partners with the Central Iowa Center for Independent Living in teaching clients how to utilize DART

services.

ACTION STEP: Increase outreach to other human service agencies whose

clients utilize the bus.

TIMELINE: SPRING 2010

d. Unlimited Access - Advertising for the Unlimited Access Program is currently word of mouth, DART does little marketing of the program due to

staff and technology constraints.

ACTION STEP: Create an advertising brochure for the Unlimited Access program that could be sent to companies throughout the metro. The brochure would include information on how to get started and the

benefits.

TIMELINE: FALL 2010

e. RideShare – DART had a promotion this winter to encourage use of

RideShare by offering \$10.00 Amici Espresso gift cards for new riders.

ACTION STEP: Execute a new campaign quarterly to bring awareness to

the RideShare program.

TIMELINE: All Year

2) Increase Number of Sheltered Stops

a. DART currently has 27 shelters and is working on the installation of an

additional 2.

ACTION STEP: Increase the number of shelters by 5 every year.
