D. RideShare Survey Results – Rebecca Lovig, RideShare Manager
Lovig shared the results of a survey of RideShare customers
regarding the increase of fares. She shared possible
approaches for raising fares – in larger amounts as needed,
or in smaller amounts in regular intervals – and solicited
feedback. Van Genderen, a RideShare customer, said
RideShare's approach to raising fares was fair and generous.
Ott questioned the use of perks for RideShare drivers. Van
Genderen said that eliminating perks for drivers would
guarantee the loss of drivers from the program.
